The above-mentioned Contracting Authority hereby provides you with the following explanation of the tender conditions relating to the above-mentioned small-scale public tender.

## **Questions from the Tenderer:**

- 1. It requests: "In this workplace the expression vector is introduced into the live larvae of Drosophila melanogaster using the PhiC31 system". Following the service name of the tender is" Drosophila melanogaster embryo microinjection for germline transformation using the PhiC31 system, including Injection, and balancing of resultant lines", I would like to confirm that where should we inject into, embryos or larvae?
- 2. It requests: ", which is inserted at a precisely determined 3rd place in the chromosome (i.e., between attR and attL)". The working PhiC31 system in Drosophila is the recombination between aatP and attB. Just to confirm that will we be requested to perform recombination between attR and attL?
- 3. It requests: "The prepared Drosophila are analysed by using SSR (Single Sensillum Recording), then they are sent back to the Czech Republic to EXTEMIT-K team and further analysed". The SSR is not mentioned in the service name of the tender FLD 008 and Methodological procedure requirements. Is SSR required for the performance?
- 4. We checked with banks in Taiwan, but unfortunately, we can't receive inward remittance in CZK. We understand that the procurement payment is in CZK. Is it possible to specify the remittance currency in EUR or USD?
- 5. I am confused about the tender submission. Are both printed form and electronic form required?

## **Explanation of Tender Conditions No. 2:**

- Ad 1) There is a mistake on our side early stage embryos, of course. We want germline transformation, after all.
- Ad 2) We are using pUASg.attB, which is used for attB/attP integration.
- Ad 3) No, the SSR will be done by us later.
- Ad 4) It will be done via Western Union bank, our payment will be sent in CZK, but you will receive it in USD or EUR (depends on what you prefer). It will be transferred at the current exchanged rate.
- Ad 5) No, one of these two options is good enough. You can send it in printed or electronic version.
