Explanation of Tender Conditions No. 2:

The Contracting Authority states that with regard to possible tenderers from outside of the Czech Republic, it has changed the conditions for the submission of tenders:

Point 8

Original text:

The Tender shall be submitted in electronic form only, exclusively through an electronic tool on the profile of the Contracting Authority. The Contracting Authority shall not allow the submission of Tenders in paper form or in electronic form in any other way than in the form specified above.

New text:

The Tender shall be submitted in two counterparts, the original and a copy, in writing and in English. The Tender shall also contain a non-rewritable data carrier, e.g. CD-R with the required documents.

The pages of the Tender shall be secured against unauthorized manipulation. The Tender shall be submitted in an opaque envelope, closed or sealed in such a way as to exclude possible manipulation of the contents of the envelope without breaking it.

The Tender shall be submitted at the address for the submission of tenders. The Tender may be delivered in person, via the holder of a postal license or by courier service to the mailing room at the registered office of the Contracting Authority so that it is delivered within the deadline for submission of tenders. The Tender cannot be delivered electronically or via a data box.

Point 10

Original text:

Tenders shall be submitted in electronic form only (see also Article 8, herein). The Tenderer may submit the Tender in electronic form throughout the entire period for the submission of tenders,

exclusively via **the electronic tool on the profile of the Contracting Authority** (https://zakazky.czu.cz).

The time for submission of Tenders shall be governed by the system time in the electronic tool of the Contracting Authority.
