II.

Předmět smlouvy

- 2.1. Touto smlouvou se prodávající zavazuje dodat kupujícímu licence software a služby netrvalého charakteru, tzv. subskripce, v rámci programu Academic License Agreement (dále jen "ALA") od společnosti MicroFocus Ireland Software Limited, Attn. Tax Department, Corrig Court, Corrig Road, Sandyford Business Park, Dublin 18, Ireland (dále též jen "MicroFocus") po dobu tří let ve třech dodávkách vždy s platností licencí na jeden rok.
- 2.2. Dodávky licencí a služeb dle předmětu smlouvy mohou být realizovány pouze na základě uzavřené aktivní smlouvy Academic License Agreement (dále jen "smlouva ALA") mezi kupujícím a poskytovatelem licencí.
- **2.3.** Používání licencí software MicroFocus se řídí smlouvou ALA, která je nedílnou součástí této smlouvy jakožto její příloha č. 2.

- **2.4.** Prodávající se zavazuje dodat licence software, které jsou předmětem této smlouvy v množství, dodacích lhůtách a za dalších podmínek stanovených touto smlouvou.
- **2.5.** Kupující se zavazuje převzít licence software a zaplatit sjednanou cenu podle podmínek sjednaných v této smlouvě.
- **2.6.** Předmětem této smlouvy jsou následující licence software a služby subskripce v rámci programu Academic License Agreement od MicroFocus:

III. Způsob, termín a místo poskytování licencí

- **3.1.** Dodávky licencí budou realizovány na základě aktivní smlouvy ALA, která byla oboustranně podepsána kupujícím a výrobcem licencí.
- **3.2.** Prodávající zavazuje dodávat licence software elektronicky odpovědné osobě kupujícímu: Jan Bureš, na e-mailovou adresu: buresj@rektorat.czu.cz
- **3.3.** Licence software MicroFocus budou dodány kupujícímu ve třech dodávkách:
 - 1. dodávka licencí software v rozsahu čl. 2.6. této smlouvy do 10 dní ode dne podpisu této smlouvy.
 - 2. dodávka licencí software v rozsahu čl. 2.6. této smlouvy do 30. března 2023.
 - 3. dodávka licencí software v rozsahu čl. 2.6. této smlouvy do 30. března 2024.
- **3.4.** Smlouva se uzavírá na období 3 let se třemi dodávkami licencí netrvalého charakteru, tzv. Subskripcí MicroFocus dle čl. 2.6 této smlouvy a v rozsahu dle čl. II. této smlouvy.

IV. Cena a platební podmínky

- **4.1.** Smluvní strany se dohodly, že za předmět smlouvy uvedený v čl. II. bude platit kupující prodávajícímu každý rok částku uvedenou v příloze č. 1 této smlouvy.
- **4.2.** Daň z přidané hodnoty bude stanovena a odvedena v souladu s právními předpisy platnými a účinnými v době uskutečnění zdanitelného plnění.
- **4.3.** Rozpis celkové ceny a jednotlivých položek předmětu smlouvy je uveden v příloze č. 1 smlouvy.
- 4.4. Cena je sjednána jako nejvýše přípustná, včetně všech poplatků a veškerých dalších nákladů spojených s plněním předmětu této smlouvy. Cena zahrnuje veškeré náklady prodávajícího. Kupní cena zahrnuje i případné náklady na správní poplatky, daně, cla, schvalovací řízení, provedení předepsaných zkoušek, zabezpečení prohlášení o shodě, certifikátů a atestů, převod práv, pojištění, přepravní náklady apod.
- 4.5. Cena bude uhrazena v CZK, přičemž je stanovena na základě aktuálního devizového kurzu USD. Dojde-li po uzavření smlouvy ke změně kurzovního poměru obou měn, musí být určený peněžní závazek zaplacen tak, aby částka v zajišťující měně (USD) zůstala nezměněná. Při tom je rozhodný devizový kurz vyhlášený ČNB v době podání nabídky prodávajícím v zadávacím řízení k veřejné zakázce, jež vedlo k uzavření této smlouvy, a v den vystavení faktury podle odst. 4.6. tohoto článku.
- **4.6.** Cena za poskytování předmětu smlouvy bude uhrazena na základě faktury daňového dokladu. Faktura bude vystavena v den dodání elektronických licencí software za každou ze tří dodávek licencí software s platností vždy na jeden rok.
- 4.7. Daňový doklad faktura musí obsahovat všechny náležitosti řádného účetního a daňového dokladu ve smyslu příslušných právních předpisů, zejména zákona č. 235/2004 Sb., o dani z přidané hodnoty, ve znění pozdějších předpisů. V případě, že faktura nebude mít odpovídající náležitosti, je kupující oprávněn ji vrátit ve lhůtě splatnosti zpět prodávajícímu k doplnění, aniž se tak dostane do prodlení se splatností. Lhůta splatnosti počíná běžet znovu od opětovného doručení náležitě doplněné či opravené faktury kupujícímu.
- 4.8. Splatnost faktury je 30 dnů ode dne jejího prokazatelného doručení kupujícímu. Fakturu je prodávající povinen doručit elektronicky prostřednictvím následující e-mailové adresy: faktury_oikt@czu.cz. Jiné doručení nebude považováno za řádné s tím, že kupujícímu nevznikne povinnost fakturu doručenou jiným způsobem uhradit.
- **4.9.** Za den platby se považuje den odepsání fakturované částky z bankovního účtu kupujícího ve prospěch bankovního účtu prodávajícího.
- 4.10. Úhrada kupní ceny nebo její části bude prodávajícímu převedena na jeho účet zveřejněný správcem daně podle § 98 zákona č. 235/2004 Sb., o dani z přidané hodnoty, ve znění pozdějších předpisů, a to i v případě, že na faktuře bude uveden jiný bankovní účet. Pokud prodávající nebude mít bankovní účet zveřejněný podle § 98 zákona č. 235/2004 Sb., o dani z přidané hodnoty, ve znění pozdějších předpisů, správcem daně, provede kupující úhradu na bankovní účet až po jeho zveřejnění správcem daně, aniž by byl kupující v prodlení s úhradou. Zveřejnění bankovního účtu správcem daně oznámí prodávající bezodkladně kupujícímu.

V. Práva a povinnosti stran

- **5.1.** Prodávající je povinen dodat zboží v dohodnutém množství, jakosti a provedení. Veškeré zboží dodávané prodávajícím kupujícímu z titulu této smlouvy musí splňovat kvalitativní požadavky dle této smlouvy.
- **5.2.** Prodávající je povinen dodat zboží bez vad kupujícímu v souladu s podmínkami této smlouvy, přičemž za řádné dodání zboží se považuje jeho převzetí kupujícím.
- **5.3.** Prodávající je povinen kupujícímu předat doklady, které jsou nutné k převzetí a k užívání zboží a provést zaškolení obsluhy. Vše výlučně v českém jazyce a podle předpisů platných v ČR, pokud nebude dohodnuto jinak.
- **5.4.** Prodávající je povinen neprodleně vyrozumět kupujícího o případném ohrožení doby plnění a o všech skutečnostech, které mohou předmět plnění znemožnit.
- **5.5.** Prodávající odpovídá kupujícímu za škodu způsobenou porušením povinností podle této smlouvy nebo povinnosti stanovené obecně závazným právním předpisem.

VI. Sankční ujednání

- **6.1.** V případě nedodržení termínu dodání je prodávající povinen uhradit kupujícímu smluvní pokutu ve výši 0,05 % z celkové ceny předmětu smlouvy vč. DPH za každý i započatý kalendářní den prodlení.
- **6.2.** Kupující je povinen zaplatit prodávajícímu za prodlení s úhradou faktury po sjednané lhůtě splatnosti úrok z prodlení ve výši 0,05 % z dlužné částky včetně DPH dle příslušné faktury za každý byť započatý den prodlení.
- **6.3.** Kupující je oprávněn od této smlouvy odstoupit v případě, že prodávající bude v prodlení s dodávkou předmětu plnění po dobu delší než třicet dní.
- **6.4.** Prodávající je oprávněn od této smlouvy odstoupit v případě, že kupující bude v prodlení s úhradou svých peněžitých závazků vyplývajících z této smlouvy po dobu delší než třicet dní.
- **6.5.** Kupující je oprávněn od smlouvy odstoupit v případě, že podle údajů uvedených v registru plátců DPH se prodávající stane nespolehlivým plátcem DPH.
- **6.6.** Odstoupení od smlouvy se nedotýká zejména nároku na náhradu škody, a smluvní pokuty.

VII.

Záruka za jakost, podmínky hlášení vad spojených s dodávkami licencí software

- **7.1.** Záruční podmínky dodávaných produktů se řídí smlouvou ALA uvedenou v čl. 2.3. této smlouvy. Záruční doba počíná běžet dnem dodání licencí kupujícímu způsobem popsaným v čl. 3.2 této smlouvy.
- **7.2.** Kupující je povinen písemně ohlásit prodávajícímu záruční vady neprodleně. Odstranění záručních vad provede prodávající bezplatně ve lhůtě maximálně 5 pracovních dní počínaje dnem následujícím po písemném ohlášení vady, případně prodávající dohodne s kupujícím

jinou dobu odstranění reklamované vady. V případě nedodržení těchto termínů je kupující dále oprávněn nedostatky nechat odstranit třetí osobou na náklady prodávajícího, a to i bez předchozího upozornění na tuto skutečnost.

- **7.3.** V případě odstranění vady v záruční době se tato prodlužuje o dobu od oznámení závady kupujícím po její odstranění prodávajícím.
- 7.4. Reklamaci lze uplatnit nejpozději do posledního dne záruční doby, přičemž i reklamace odeslaná v poslední den záruční doby se považuje za včas uplatněnou. - **8.1.** Prodávající není bez předchozího písemného souhlasu kupujícího oprávněn postoupit práva a povinnosti z této smlouvy na třetí osobu.
- **8.2.** Smluvní strany jsou povinny bez zbytečného odkladu oznámit změnu údajů uvedených v záhlaví smlouvy.
- **8.3.** Prodávající garantuje, že poskytnutím licenčních práv k software neporušuje práva třetích stran ani zákon o právu autorském.

IX.

Závěrečná ustanovení

- **9.1.** Vztahy mezi stranami se řídí českým právním řádem. Ve věcech smlouvou výslovně neupravených se právní vztahy z ní vznikající a vyplývající řídí příslušnými ustanoveními občanského zákoníku a ostatními obecně závaznými právními předpisy.
- 9.2. Tato smlouva nabývá platnosti dnem jejího podpisu oběma smluvními stranami a účinnosti v souladu se zákonem č. 340/2015 Sb., o zvláštních podmínkách účinnosti některých smluv, uveřejňování těchto smluv a o registru smluv (zákon o registru smluv), ve znění pozdějších předpisů. Smluvní strany se dohodly, že plnění poskytnutá vzájemně mezi smluvními stranami dle předmětu této smlouvy před její účinností se započítají na plnění dle této smlouvy.
- **9.3.** Tato smlouva se uzavírá na dobu určitou, tzn. na dobu tří let ode dne doručení první dodávky licencí software.
- **9.4.** Smluvní strany budou vždy usilovat o přátelské urovnání případných sporů vzniklých ze smlouvy. Pokud nebylo dosaženo přátelského urovnání sporu ani do 30 pracovních dnů po jeho prvním oznámení druhé straně, je kterákoliv ze smluvních stran oprávněna obrátit se se svým nárokem k příslušnému soudu.
- **9.5.** Veškeré změny či doplnění smlouvy lze učinit pouze na základě písemné dohody smluvních stran. Takové dohody musí mít podobu datovaných, číslovaných a oběma smluvními stranami podepsaných dodatků smlouvy.
- **9.6.** Tato smlouva se vyhotovuje a podepisuje v elektronické podobě.

- 1.2 Annual Period means the period beginning on the first day of the month following the Effective Date and ending one year thereafter, and each consecutive one-year period thereafter during the ALA Term.
- 1.3 Authorized Users means Customer's students, faculty and administrative personnel for which the ALA License Fee has been paid.
- 1.4 Customer means an educational organization that has been approved by Novell and has signed this Agreement. The Customer signing this Agreement will be responsible for the obligations of other schools or entities which participate under this Agreement.
- 1.5 Effective Date means the later of the dates this Agreement is executed by Customer and Novell.
- 1.6 FTE means a Full-Time Equivalent faculty personnel, staff, or student. The number of Customer's FTEs shall be calculated as the sum of (a) the number of full-time faculty and staff plus the total number of part-time faculty and staff work hours in an average work week divided by 40; and (b) the number of full-time students plus the total number of part-time student credit hours divided by the number of credits that Customer uses to identify full-time status.
- 1.7 Internal Use means use by Authorized Users, consultants and contractors for Customer's internal operations.
- 1.8 Master Software means master media available from Novell

from which Customer may make copies to install the Software.

- 1.9 Software means the Novell software licensed under this ALA as identified on the ALA Annual Fee Worksheet.
- 1.10 Update means a fix or compilation of fixes released by Novell to correct operation defects (program bugs) in the Software.
- 1.11 Upgrade means any new version of a Software product which bears the same product name, including version changes evidenced by a number change immediately to either the right or left of the decimal (for example, Novell Identity Manager 3.5 to 3.6 or GroupWise 7.0 to 8.0). If a question arises as to whether a product offering is an Upgrade or a new product, Novell's opinion will prevail provided Novell treats the product offering the same for its end user customers generally.
- 1.12 Workstation means (a) a computer that is owned or leased and operated by Customer, and (b) any other personal computer that is allowed to connect to Customer's network. - Licenses. Subject to the Agreement provisions, Novell grants and Customer accepts a non-exclusive, non-perpetual, non-transferable license to use the Software identified on the ALA Annual Fee Worksheet for Internal Use by Authorized Users on Customer's Workstations. Software that includes non-Novell products, evaluation products, or products requiring key activation, may require additional purchase if Customer chooses to be licensed to use such products.
- 2.1 Department Workstation. If Customer purchases under the ALA for less than an entire organization, such purchase must be made using Department Workstation pricing, and only Authorized Users within the department or organizational unit for which the Workstation price was paid are licensed to use the Software.
- 2.2 Limited Warranty. The Software is subject to the license terms and restrictions set forth in the applicable End User License Agreement ("EULA") that accompanies a Software product. Each EULA for a product licensed under this ALA is incorporated into this Agreement. If there is a conflict between the terms of the EULA and this Agreement, the Agreement terms shall govern. For 90 days from Customer's date of purchase, Novell warrants that (1) any media on which the Software is delivered is free from physical defects; and (2) the Software will substantially conform to the applicable Software documentation. If the defective items are returned to Novell or if Customer reports the nonconformity to Novell within 90 days from the date of purchase, Novell will at its sole discretion either resolve the nonconformity or refund the ALA License Fee Customer paid for the Software in question. Novell will select a carrier, prepay the freight and invoice Customer for freight and any handling costs. Destinations for E.U. countries will be Customer's nominated delivery point; for non-E.U. countries, destination will be the point of import. The term C.P.T. does not include the payment by Novell of taxes or any applicable import duties.
- 4.2.1 <u>Electronic Delivery</u>. For Software delivered by Novell hereunder by electronic means directly to Customer outside the U.S.A., Customer's license to use the Software shall arise at the location of the computer on which the Software is first used by Customer, and delivery of the Software so supplied shall be deemed to occur where download is completed successfully at

- the destination computer. For deliveries within EMEA (i.e. originating in Ireland), the Software shall be considered delivered using the Incoterm (2010) C.P.T. (Carriage Paid To) Destination.
- 4.3 <u>Title & Risk of Loss.</u> For shipment within the United States, title to any deliverables, exclusive of Novell's rights to intellectual property, and risk of loss will pass to Customer upon delivery to Customer's carrier. For shipments from the U.S. to outside the U.S., title to and risk of loss will remain with Novell until the shipment arrives at the importing country's entry port (or at a bonded warehouse within Canada or Mexico if Customer so requests shipment). For shipments originating in Ireland, title to and risk of loss passes to Customer at the Irish shipment point. Notwithstanding the above provisions, no title to Master Software is transferred to Customer.
- 4.4 <u>Duplication</u>. All copies of Software must be made from the Master Software and must reproduce any serial numbers and all proprietary rights notices.
- 5 Upgrades and Technical Support. If Novell commercially releases any Upgrades and/or Updates during the period covered by Customer's ALA License Fee, Novell will make such Upgrades and/or Updates available to Customer within a reasonable period of time after they become commercially available. No technical support is included in the ALA. Technical support may be purchased under a separate contract.

6 Placing Orders and Payment Terms.

- 6.1 ALA License Fee. Customer must submit a completed ALA Annual Fee Worksheet and/or a proper purchase order to Novell or an authorized Novell academic fulfillment agent for their ALA License Fee at least 15 days prior to the expiration date of Customer's then-current ALA Annual Period ("Order Due Date"). Orders submitted after the Order Due Date will incur a late order fee equal to 10% of the ALA License Fee. The late order fee is in addition to annual ALA License Fees, late payment interest, and other obligations that may be due and payable. To participate in the ALA program, Customer's ALA License Fee, as calculated per the ALA Annual Fee Worksheet, must be a minimum of USD \$5,000. The non-refundable ALA License Fee will be due and payable in USD within 30 days from the date of invoice. However, for orders requesting shipment and billing to a country whose currency is required by the applicable Novell price list, the purchase orders must be issued, and the fees paid in the required currency. Orders issued in response to quotes must correspond to the currency in which the quote was made.
- 6.2 <u>Price and Product Changes</u>. Novell may revise the ALA Annual Fee Worksheet at any time to (a) change the prices for Software licenses or other deliverables, or (b) add or delete available products or other offerings. Separate from Customer's ALA License Fee purchases, Customer may purchase Novell licenses available under Novell's Volume License Agreement Program ("VLA"). VLA terms and conditions shall apply to such purchases.
- 6.3 <u>Taxes</u>. Prices are exclusive of all applicable taxes. Customer agrees to pay and bear the liability for all applicable taxes associated with this Agreement or any Schedule thereto, including but not limited to sales, use, excise, added value and similar taxes and all customs, duties or governmental impositions, but excluding taxes on Novell's net income, such as a withholding tax required under local law. Customer agrees to provide Novell with the original receipt documenting any withholding tax levied. Any tax or duty Novell may be required to collect or pay upon the delivery or distribution of the Novell

Software will be paid by Customer, and such sums shall be due and payable to Novell upon delivery. If Customer claims a tax exemption, Customer must provide Novell with valid tax exemption certificates in advance of any remittance otherwise required to be made by Novell on behalf of, or for the account of, Customer. 6.4 <u>Late Payments</u>. Payments made later than the invoice due date will accrue interest from the date due to the date paid at the lesser of the rate of 12% per year or the highest rate allowed by applicable law. Customer will pay reasonable costs and attorney's fees if Novell is required to undertake collection measures against Customer.

7 Term and Termination.

- 7.1 <u>Term.</u> This Agreement will begin on the Effective Date and will remain in effect for a period of three years after the first day of the month following the Effective Date ("Term"). At the end of the Term, this Agreement will be automatically renewed for additional three-year terms until either party gives written notice at least 30 days prior to the end of the Term.
- 7.2 <u>Termination for Cause</u>. Either party may terminate this Agreement upon written notice for the breach by the other party of any material term, if such breach is not cured within 30 days following receipt of written notice of breach from the non-breaching party. If Customer terminates this Agreement for cause, Novell will refund Customer any prorated portion of the ALA License Fees paid for the period beyond termination.
- 7.3 Effect of Termination. Upon Agreement termination, all licenses and rights granted under the ALA will immediately terminate, and Customer shall destroy all Master Software and remove all Software copies. Within 30 days after termination Customer shall certify in writing that all copies of Software for which no continuing licenses have been separately purchased have been removed and that all fees due have been paid. The terms of the applicable EULAs shall govern Customer's use of any continuing licenses that Customer purchases.
- Formal Audits. Customer will keep complete and accurate records of all Software use. Novell may at its expense and upon no less than 5 working days written notice audit Customer installation, use, or access of the Software and related records and ALA payments. As part of such audit, Novell is entitled to obtain physical and electronic data concerning all Software installation, use, or access at each of Customer's offices, regardless of their location. At Novell's option, the audit may be conducted either by Novell or by its authorized representative, and will not interfere unreasonably with Customer business activities. An audit will be conducted no more often than once per calendar year at a location, unless a previous audit disclosed a material discrepancy. If an audit shows Customer to have underpaid fees, Customer must promptly purchase from Novell at list price sufficient licenses and Maintenance to support the actual deployment, including Maintenance to support the shortfall. If an audit shows Customer has underpaid amounts owing by more than 5%, Customer will also within 30 days pay

the reasonable expenses of the audit.

9 LIABILITY LIMITATIONS.

- 9.1 Indirect Damages. TO THE EXTENT ALLOWED BY APPLICABLE LAW, NEITHER NOVELL NOR CUSTOMER WILL BE LIABLE FOR ANY INDIRECT, SPECIAL, INCIDENTAL, OR CONSEQUENTIAL DAMAGES WHETHER UNDER CONTRACT OR IN TORT (INCLUDING, BUT NOT LIMITED TO, DAMAGES FOR INTERRUPTION OF BUSINESS, LOSS OF BUSINESS, LOSS OF PROFITS AND LOSS OF USE OF DATA) RELATED TO OR ARISING OUT OF THIS AGREEMENT, EVEN IF THE BREACHING PARTY HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. THIS SECTION DOES NOT APPLY TO VIOLATIONS BY EITHER PARTY OF THE OTHER PARTY'S INTELLECTUAL PROPERTY RIGHTS.
- 9.2 <u>Direct Damages</u>. Novell's liability for damages of any type arising out of or related to this Agreement shall be limited to the greater of 1.25 times the actual amounts paid by Customer for the licenses, service, or deliverable in question, or Euro €10,000. This subsection does not apply to any damages for personal injury or tangible property caused by the negligence or willful default of Novell.

10 General Terms.

- 10.1 <u>Notices</u>. Notices to a party must be in writing and sent to the party's address provided above or such other address as a party may provide in writing. Notices may be delivered in a format reasonably chosen by the notifying party.
- 10.2 Confidentiality Obligations. The receiving party of Confidential Information will exercise reasonable care to protect any Confidential Information from unauthorized disclosure or use. The receiving party may disclose Confidential Information only to its employees or agents with a need to know such information and will inform such employees and agents by way of policy or agreement that they are bound by confidentiality obligations. "Confidential Information" means the terms of this Agreement and any other information that (i) if disclosed in tangible form, is marked in writing as confidential, or (ii) if disclosed orally or visually, is designated orally at the time of disclosure as "confidential." Confidential Information will not include information (a) already in the receiving party's possession without obligation of confidence; or (b) independently developed by the receiving party; or (c) that becomes available to the general public without breach of this Agreement; or (d) rightfully received by the receiving party from a third party without obligation of confidence; or (e) released for disclosure by the disclosing party with its written consent; or (f) required to be disclosed by law, regulation, or court order. These confidentiality obligations will survive 3 years after expiration or termination of this Agreement. Novell retains the right to use its knowledge and experience (including processes, ideas, and techniques) learned or developed in the course of providing any services to Customer.
- 10.3 Law. Each party will, at its own expense, comply with any applicable law, statute, administrative order, or regulation. This Agreement will be governed by the substantive laws of the State of Utah, unless the laws of the state, province, or country of Customer's domicile require otherwise, in which case the laws so required will govern. However, if Customer's principal residence is in (a) a member state of the European Union or (b) a member state of the European Free Trade Association (c) the Republic of South Africa, or (d) Canada, the governing law is that of the country of Customer's principal residence (and for Canadian customers, the law of the Province of Ontario). If Customer's

principal residence is in any other country in Europe the applicable law will be the law of the Federal Republic of German. If Customer's principal residence is in the Middle-East or Africa (except South Africa), the applicable law will be the law of England. If a party initiates legal proceedings related to this Agreement, the prevailing party will be entitled to recover reasonable attorney's fees.

10.4 <u>Assignment</u>. This Agreement and any rights or obligations under it may not be transferred, assigned, or sublicensed without the prior written approval of Novell. Any such attempted action, by operation of law or otherwise, will be invalid.

10.5 Severability / Waiver. If a provision is held invalid or unenforceable, the provision will be severed to the extent of such invalidity, or unenforceability, and shall not affect or impair the remaining provisions hereof. No waiver of any contractual right shall be effective unless made in writing signed by an authorized representative of the waiving party.

10.6 Entire Agreement. This Agreement sets forth the entire agreement and understanding between the parties as to its subject matter. This Agreement supersedes all prior and contemporaneous agreements, proposals and statements on this subject matter. Except as may be expressly provided for in this Agreement, including Novell's right to revise ALA prices, this Agreement may only be modified in a writing signed by authorized representatives of each party. Purchase order terms will not modify this Agreement unless the parties agree otherwise in writing.

10.7 Export Compliance. Any products or technical information provided under this Agreement may be subject to U.S. export controls and the trade laws of other countries. The parties agree to comply with all export control regulations and to obtain any

required licenses or item classification to export, re-export or import deliverables. 10.9 <u>Survival</u>. The provisions of this Agreement which by their nature extend beyond termination of the Agreement, including section 2 (Licenses), 8 (Formal Audits), 9 (Liability Limitations) and 10 (General Terms), will survive termination of the Agreement.

10.10 Intellectual Property Rights/Remedies. Nothing in this Agreement waives or limits extra-contractual rights or remedies available to Novell to protect its rights in the Software, including those available under U.S. copyright law, international treaties, or national copyright and intellectual property laws of the countries in which Customer may use the Software.
